

# 5. REQUEST TO CLASSIFY A FILM (DCS)

## 1. <u>Purpose of Report</u>

To determine the classification of a film, "Sons of Cuba" in accordance with the British Board of Film Classification guidelines so that it can be shown in The Screen at Oxted.

## 2. <u>Recommendation</u>

The film, Sons of Cuba be awarded an appropriate viewing classification

## 3. <u>Background</u>

- 3.1 The Licensing Act 2003 provides that where a premises licence or club premises certificate authorises the exhibition of a film, it must include a condition requiring the admission of children to films to be restricted in accordance with the recommendations given either by the British Board of Film Classification (BBFC) or by the licensing authority itself.
- 3.2 The BBFC is an independent non-governmental body funded through the fees it charges to those who submit films and video works for classification. The BBFC fees can be prohibitive for films intended for a small viewing audience and there is provision for premises to ask their local licensing authority to classify a film instead. The Everyman Media Group wishes to show the film "Sons of Cuba", which does not have a BBFC classification, at The Screen at Oxted.
- 3.3 Sons of Cuba is a documentary lasting 88 minutes about a boys' boxing academy in Cuba, covering its progress towards an annual boxing competition.
- 3.4 The BBFC classifies films in accordance with its published guidelines which are based on extensive research into public opinion and professional advice. It currently classifies films in the following way: A copy of the BBFC guidelines is circulated separately.
  - U Universal suitable for audiences aged 4 years and over
  - PG Parental Guidance. Some scenes may be unsuitable for young children
  - 12A Passed only for viewing by persons aged 12 years or older or persons younger than 12 when accompanied by an adult
  - 15 Passed only for viewing by persons aged 15 years or older
  - 18 Passed only for viewing by persons aged 18 years or older
- 3.5 Where a licensing authority has made a recommendation on the restriction of admission of children to a film, notices are required to be displayed both inside and outside the premises so that persons entering can readily be made aware of the classification attached to any film or trailer.
