237. MOTION SUBMITTED BY COUNCILLOR GAFFNEY UNDER STANDING ORDER 7

Under Standing Order 12(10), Councillor Gaffney sought the Council's consent to alter the motion submitted under Standing Order 7 and which had been set out in the Council Book. The Council gave consent, and Councillor Gaffney introduced the motion attached at Appendix B.

Councillor Groves, seconded by Councillor Cooper, proposed an amendment to the motion, with the effect of removing the final paragraph and replacing it with the following paragraphs:

"The Council is not making a political point but, as a user of Surrey's Highway's service, wishes to point out what may be internal management issues and how the presence of a Highways officer at planning committees, coupled with more site visits to assess conditions on the ground, would greatly improve the technical planning process and outcomes for the residents of Tandridge.

It is felt that communication between Surrey County Council and Tandridge District Council could easily be improved with the reinstatement of the very useful Local Committee joint meetings."

Upon being put to the vote, the amendment was not agreed.
