The land is to be appropriated to assist with the development plans for the Warren Lane depot/122 Mill lane site; To facilitate the carrying out of development within the Council's house building programme by ensuring that the land and property in question is appropriated for the correct statutory purpose under Section 122 (1) of the Local Government Act 1972. It is considered that the public benefit of appropriation of the sites for planning purposes is likely to outweigh any private rights which might be interfered with as a result of appropriation for planning purposes.

The process of appropriation itself does not have any positive impact, the related delivery of the affordable housing scheme proposed has a direct improvement:

- A disabled person and their household due to the fully accessible 3 bed wheelchair home that will be delivered allowing increased independence and improved quality of life
- All units are family sized accommodation (2 and 3 beds), they will be delivered as affordable rent (70% of open market rent) and will be retained by the council and let to families in housing need. The properties will be built to net zero carbon, with high levels of insulation and air source heat pumps which should reduce fuel bills significantly. A long term affordable, warm and secure family home will assist in reducing child poverty and the related outcomes such as improved physical and mental health and educational

We have been unable to identify anybody with third party rights across the land so cannot assess negative impacts.
