From 22:27 hours on Saturday 3<sup>rd</sup> July 2021 ,Police were called via multiple 999 calls to the SPAGHETTI TREE, LIMPSFIELD ROAD, WARLINGHAM, for a large fight at the location.It had been reported to police that up to 50 persons were fighting in small groups and one caller had heard that a person had been stabbed .Callers were also reporting that people were being hit by flying glass and that a metal pole was being used as a weapon.Another caller told the police to 'hurry up' and that 'someone was going to die'.Officers arriving at the scene, were met with hostility and it became clear that a violent disorder had taken place and multiple victims were being identified, both guests and staff members .At the time of writing, seven Actual Bodily Harm victims have been identified and one Grevious Bodily Harm victim. CCTV has been obtained which provides images of the incident. [information redacted as it relates to evidence that may be sub judice]. The reports to the police and the CCTV evidence show how serious disorder took place and how the door supervisors were powerless to bring any control to the venue .It is reported from the public after the incident occurred that loud music was being played during the day and that police have recorded intoxication was a factor in this violent disorder. [information relates to evidence that may be sub judice]. Whilst this investigation is ongoing there is a risk that persons at the venue could be subject to reprisals and that a similar incident could take place where intoxication is evident , door superviosrs are unable to exercise control and large guest numbers are involved.Surrey Police believe that as an interim step the premises licence is suspended ,so the premises can be closed and the future of the premises licence can be reviewed.

Notes for guidance:

1. A certificate of the kind mentioned in the form must accompany the application in order for it to be valid under the terms of the Licensing Act 2003. The certificate must explicitly state the senior officer's opinion that the premises in question are associated with serious crime, serious disorder or both.

Serious crime is defined by reference to section 81 of the Regulation of Investigatory Powers Act 2000. In summary, it means:

- conduct that amounts to one or more criminal offences for which a person who has attained the age of eighteen and has no previous convictions could reasonably be expected to be sentenced to imprisonment for a term of three years or more; or
- conduct that amounts to one or more criminal offences and involves the use of violence, results in substantial financial gain or is conduct by a large number of persons in pursuit of a common purpose.

Serious disorder is not defined in legislation, and so bears its ordinary English meaning.
