Hello Jeanette,

The delay is no big problem. I have submitted my works order without this bit. The only slight issue is that the traffic regulation order will be amended to show the change, so the 1 hour parking bays will still be there on the ground, but will not be enforceable, but I don't think that will be much of an issue as hardly anyone will be aware of it. This also means that if your committee approves the change then we can implement it straightaway. If they don't, we would just change the traffic order back to how it was before as part of our next parking review, which is due to start shortly after your committee meeting.

We formally advertised our intention to make all the parking review changes on 13 January, by way of a notice in the Surrey Mirror. At the same time we also put up notices on street light columns and parking bay sign posts and sent postcards to local addresses advising them that changes to parking were planned with a link to our website for them to find out the details. There was then a 28 day period (ending on 10 February) for people to comment on and/or object to any of the proposed changes. In respect of this proposal, we received no comments at all. I was a bit surprised that none of the shops commented about the loss of the parking bays, as we sent them all a postcard.
