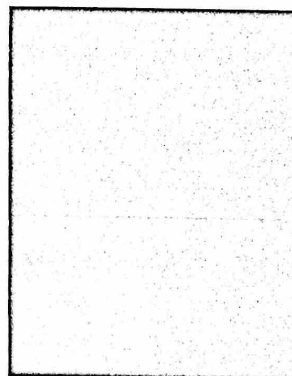

(a) under which goods or services are to be provided or works are to be executed; and

(b) which has not been fully discharged.

Land. Any beneficial interest in land which is within the Council's area (e.g. my home).

Licences. Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer.

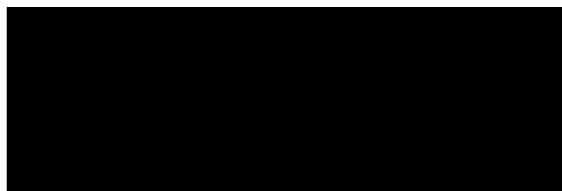


